

**Richmond Land Bank  
Pre-Qualification Application**

Thank you for your interest in becoming Qualified Applicant for the acquisition of Richmond Land Bank (RLB) property. The RLB is committed to returning vacant, abandoned, surplus, or tax-delinquent property to productive use that benefits and enriches the community, with a priority placed on the creation of permanently affordable housing. In order to respond to a RLB Request for Proposals to receive specific land bank properties an Applicant must first be determined to be eligible through this Application, which will be reviewed on the terms of the Eligibility Policy. This Application ensures that applicants align with the mission of the RLB.

*All applicants must meet three threshold expectations by demonstrating: 1) for residential uses, a commitment to providing permanently affordable homes; 2) previous relevant experience with project/property development; 3) financial ability to carry out the proposed plan.*

Entities that are determined to be eligible may continue to apply for property for 2 years before re-certification is required. *Before making a final decision regarding an applicant's qualification, the RLB may request additional documentation or materials.*


